STANLEY WILSON being duly sworn deposes and says:

1. I am James Couri's (Couri) Assistant.
2. I make all Court filings, most hand-deliveries, and all process serving for Couri as well.
3. Couri was diagnosed with cancer (after testing) during early 2006. Couri also suffers from heart disease.
4. Couri was operated upon numerous times during many years prior to 2006, at Presbyterian Hospital. On each occasion I visited him while he was in the hospital.
5. On or about May 17, 2006 and May 31, 2006 Couri was operated on at Mt. Sinai Hospital for cancer, and was very ill.
6. At Couri's request, I picked up at Dr. Micail Shafir's office at 1021 Park Avenue, NYC, on separate occasions, 3 separate Affirmations, dated 5-23-06, 5-28-06 and 6-9-06, and promptly

delivered each of them to Referee Crespo, also on the 3 separate occasions as dated.


7. I also delivered by hand, other Medical Records of Couri's condition to Crespo as well from May 2006 through about September 2006.


8. Early June 2006 Couri went to California for Medical Care and kept in touch with me almost daily by phone, and also by fax and FedEx.

9. At or about mid to late June 2006, Couri sent to me via FedEx, Authorizations for Couri's and Affiliate Companies' Tax Returns (Federal and NY State). I recall that each one of these Authorizations were signed by him. Couri instructed me to immediately hand-deliver them to Referee Crespo, which I did, on the day I received them from Couri.

10. Furthermore, I have again, at Couri's request, reviewed the Court files regarding this Case and Crespo. I find that the Couri Exhibits discussed in my prior Affidavit Sworn to on Nov 13, 2008 are still missing. I also searched for Couri's Medical Records and the Affirmations delivered to Crespo by me. They are also missing, although they are included by in many Motions made by Couri to Crespo and to JSC Heitler and others. The Tax Authorizations that were signed by Couri that I hand delivered to Crespo are also missing from the Court File Room as well.
